




Figure 3. Typical On-Resistance vs. Drain Current and

Figure 5. Typical On-Resistance vs. Drain Current and Temperature




Figure 2. Typical Transfer Characteristic




Figure 4. Typical Transfer Characteristic




Figure 6. On-Resistance Variation with Temperature









Figure 7. On-Resistance Variation with Temperature



V<sub>SD</sub>, SOURCE-DRAIN VOLTAGE (V) Figure 9. Diode Forward Voltage vs. Current




Figure 11. Gate Charge





Figure 8. Gate Threshold Variation vs. JunctionTemperature

Figure 12. SOA, Safe Operation Area







Figure 13. Transient Thermal Resistance


