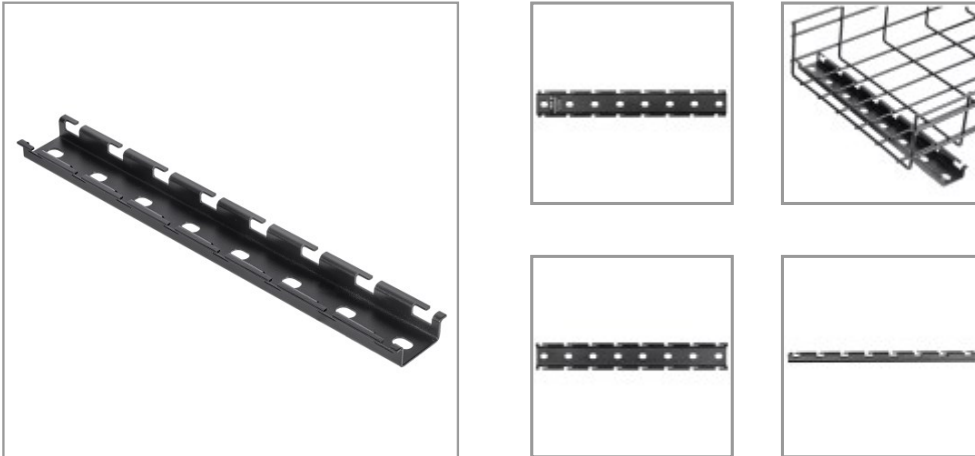


## Trapeze Hanging Cross-Bracket for Wire Mesh Cable Trays, 300 mm (12 in.)
